
Pursuant to the Court's order granting preliminary approval of the proposed Settlement Agreement ("Settlement Agreement" or "SA"), Plaintiffs respectfully seek an Order approving Fresenius Vascular Care, Inc. d/b/a Azura Vascular Care's agreed-upon payment of \$3,150,000 to be allocated as follows: (i) \$1,102,500 for Class Counsel's attorneys' fees; (ii) \$14,062.32 for Class Counsel's litigation costs and expenses; and (iii) \$2,500 Service Awards for each of the three Class Representatives (\$7,500 total).


